Financial Report

 Board reviewed financials. Motion to approve payment of claims for September by Gary Friend. Mike Wickersham second. Motion carried. Director presented 2023 TYD budget for review.

Recycling and Pollution Solution Report

- o Board reviewed host fee and recycling report.
- O Director reported that the cost of tire disposal has increased significantly over the past few years. The district's charge for tires is far below the charge other districts are asking, and far below the charge at the Randolph Farms Landfill. Director suggested an increase in District tire charges. Board discussed the increase, wanting to increase prices a little at a time. Motion to increase prices of residential tires to 2.00/per tire and 20.00/per tractor tire by Gary Friend. Mike Wickersham second. Motion carried. Any commercial tires would be taken at the same rate as the landfill, but efforts will be made to discourage commercial tires from coming to Pollution Solution.
- o Board discussed the possibility of town wide clean up days in 2024. There are a few issues, such as how to handle electronics and other HHW that would have to be addressed.

Education Report

o Director reported that the Union City HS class discussion about recycling went well. The District supported the Journey Home Benefit concert in partner with Pam Frazier and the AARC to promote upcoming events. Tonia attended an education in Marshall county and received a lot of good information. There was also an activity with the Girl Scouts in Farmland. The District also had a booth in the Take Time For You night at St Vincents

Randolph which was well received. There are several activities and outreach opportunities on the books for October and November.
